## LET'S PROTECT OURSELVES AND OUR NEIGHBORS!!

Remember that nasty rash of thefts from vehicles last summer and fall in the Towns of Sun Prairie, Bristol and Burke? Since that time, there has been a few more personal property thefts from vehicles, and over the winter there have been at least five home invasions in our Town and the surrounding area. These events can leave an individual feeling exposed and vulnerable. Isn't it about time that we step up and identify problems and weaknesses, and do our best to prevent theft from happening in our community?

Deputy Sheriff John Nelson, our community deputy, has shared some thoughts with us on how we can prevent further theft. When leaving a vehicle unattended, be sure to lock your doors, and keep



valuables out of sight. If someone can see something of value in plain view and they want it, he or she will not hesitate to gain entry into the auto through an unlocked door or to break open a window or two. away as the frost leaves. > budget for repair is by Protecting your home from invasion can be as simple as getting to letting key people know know your neighbors. Knowing your neighbors comings and goings can really be helpful in determining if a strange vehicle is in the vicinity – maybe even "casing the place". If you plan to be gone for an extended period of time have someone plow your driveway after snowfalls. Do not leave the garbage bins at the roadside – ask neighbors to pull them up to the house. Newspapers and mail left in the boxes are also key signs that the residents of the home are probably out of town. Stop your mail delivery or have someone collect it for you.

> > In a few of the most recent home invasions, entry has been made through purposely broken basement windows. You may wish to take steps to prevent entry, or install motion lights or alarms to outside areas

# EMERGENCY MEDICAL SERVICE DISTRICT #14 (EMS)

## Who do I contact if I have a medical emergency? In Dane County everyone should contact 911.

The 911 dispatch will notify the Marshall Area EMS District 14. The Town of Sun Prairie does not contract with the City of Sun Prairie EMS for medical emergency service. However, the District does have a mutual aid agreement with the city and the city will respond to an Advanced Life Support (ALS) call.

An EMS joint municipal agreement was signed between the Towns of Sun Prairie, Medina, York, and Village of Marshall forming an Emergency Medical Service District, June 30, 2005. The name given to the district is "Marshall Area EMS District 14." The "District" is governed by a commission consisting of four appointed members from each respective municipality. The purpose of the District is to provide emergency medical and ambulance services. Each municipality pays a portion of capital and operating expenses calculated by the equalization of the community. The ownership of assets is retained by the District. For example: the Town of Sun Prairie helped pay for the Public Safety Building in Marshall as well as the ambulances but they are titled to the District.

The current roster consists of 43 active members; 4-Paramedics, 23-Advanced EMTs, 12-EMTs, 3-Drivers only, and 1-Member in training. The EMS unit responded to 464 calls in 2013 of which 101 calls were from residents in the Town of Sun Prairie.

If you do see something that doesn't seem right, jot down the license plate, vehicle description or descriptions of unfamiliar people. You don't necessarily have to act on it immediately, but having information available to share with the sheriff if a theft

## Dane County Clerks Get New Voting Machines!

The DS-200 replaces the blue Eagle ballot machine. The Eagle was purchased nearly 30 years ago and parts for repairs have become unavailable. The voter will experience little change in voting with the DS-200 ballot machine. The ballot is placed on the tray and the machine takes it in just as before. Most of the changes are internal. The machine scans each ballot as it enters; a photo is taken of the ballot and placed on a flash drive in the machine along with recording data on ballot. This is a very valuable feature, if there is any question about fraud or recall or recount, each ballot can be viewed digitally or hardcop-

ies reproduced. This is a cost savings for municipalities in people-power and monies.

The DS-200 has a screen like a personal computer. I ask you to pause when placing your ballot in the machine to watch what happens on the screen. It should display "THANK YOU FOR VOTING" if the ballot was marked correct. If not, it will also tell you and ask you what you would like to do with it.

Although the ballot has changed from drawing a line to filling a oval, it can be done with a #2 pencils, ink pen (no jel pen), or maker (not highlighter). I feel this is one of the nicest changes and economical also.

Although local tax collection season is over, I want to share a friendly reminder that **the January 31**<sup>st</sup> **due date is really <u>January 31</u><sup>st</sup>. As long as you have paid in person, dropped your payment in the drop box at the Town Hall, or have the payment postmarked by January 31<sup>st</sup>, your payment is considered timely with me. Next year, I will be closing out my tax collection on the 31<sup>st</sup> of January. Payments I receive after that date by mail and within the 5 day grace period I** 

will endorse over to the County, and they will be considered timely. If you neglect to pay the taxes

before the 31<sup>st</sup> at our Town Hall, I will direct you to visit the Dane County Treasurer's office on Martin Luther King, Jr. Blvd in Madison. Thank you.

## Open Book/Board of Review

Property values in the Town if Sun Prairie are determined by our assessor, Associated Appraisal Consultants, Inc. Annually, you have the opportunity to meet with the assessor to determine if the assessed value of your

property is too high. This is called Open Book. If, after that meeting, you still wish to pursue the possibility of lowering your assessment, you can meet with the Board of Review. At that time, you would be meeting

with the Town Board, the assessor, and the Town Clerk. These meetings usually occur in April and May, respectively. Dates have yet to be set for 2014, but if you wish to meet with the assessor in April, email Cindy at <u>treas</u>-

<u>urer@townofsunprairie.info</u>, or call her at (608)837-6688. Please leave your name, address, phone number, and if possible your parcel number. She will put you on the list to be contacted when dates have been decided.

## HAVE YOU LICENSED FIDO?

*Did you know:* By State Statute 174.05, the owner of a dog more than 5 months of age on January 1<sup>st</sup> of any year, or within said year, shall annually license said dog. <u>This is state law.</u> Licensing is taken care of at the municipal level, so you can come to the Town Hall during office hours and license your beloved family dog. Late fees are \$5 per dog if not paid by April 1<sup>st</sup> of each year (State Statute 174.05(5)).

**Did you know:** Each dog must be vaccinated against rabies within 30 days after the dog reaches 4 months of age (State Statute 95.21(2)). Failure to do so may result in a penalty in the amount of \$50 - \$100 (State Statute 95.21(10)). Once again, these are state laws, and each Town, Village, and City is bound to follow state law.

**Did you know:** Licensing fees for Town of Sun Prairie residents are some of the most reasonable in our area. **Spayed/Neutered license fees are \$11 each. Unspayed/Unneutered license fees are \$16 each.** City of Sun Prairie fees are \$15/\$20, respectively. Village of Cottage Grove fees are \$13.25/\$18.25, respectively. Lastly, Town of Burke fees are \$20/\$30, respectively.

*Did you know:* As stated above, you can obtain a license in person at the Town Hall, 5556 Twin Lane Road, Marshall, WI 53559. You can also download a copy of the license application from our website, <a href="www.townofsunprairie.info">www.townofsunprairie.info</a> (follow the Permits, Licenses and Applications link and click on Dog License Information and Application) and mail your completed application and fee to Cindy L. Yelk, Treasurer, Town of Sun Prairie at the address indicated above. You could also email the application to Cindy at <a href="mailto:treasurer@townofsunprairie.info">treasurer@townofsunprairie.info</a>, and mail the fee to the office at the address above. PLEASE REMEMBER TO INCLUDE A COPY OF THE RABIES VACCINATION CERTIFICATION HOWEVER YOU LICENSE YOUR DOG.

*Did you know:* Licensing you dog and providing vaccination information is much cheaper than having to reclaim your pet from the Humane Society if your dog is picked up. Fees begin at \$40, more likely \$60, and \$15/day after the first day. Repeat offenders incur additional charges.

# WILL THE WINTER OF 2013/2014 EVER END????

It seems as though we have had ample time to practice our winter driving skills this year. Please continue to be careful as we begin to "thaw out". Road surface temperatures can fluctuate rapidly as the weather changes and the sun sets and rises. Black ice can develop quickly. Our road patrolmen are very conscientious, and work hard to make the roads as safe as possible, but it takes time to run their routes. Each driver spends about

4 hours on their route after a simple snow event. Ice events and blowing and drifting snow road clearings take longer. Please be patient, they will be in your neck of the woods as quickly as they can. **Please note: county roads (ie. T, TT, VV, N) are plowed by Dane County.** If you live on a county road and damage is done to your property by a county plow truck, you can contact Dane County at (608)266-4012.



### **MULCH - 2014**

The Town of Sun Prairie plans to have mulch delivered to our lot in the spring as soon as the weather allows. Please note, we are asking for a \$10 donation per truckload to help defray the cost of delivery. Money can be brought into the office during office hours, or you can simply slip the money into our drop box located to the left of the main entrance of the town hall (envelopes are provided in the drop box). We will have more mulch delivered throughout the summer as long as we are able to pay the delivery charge for each new load with residents' donations. When donations cease, so will the deliveries.

The mulch delivered is for the use of our residents on their own property. The mulch is not intended to be used for business use. When mulch is delivered, a notice will be added to the front page of the town web-

# Spring is bound to arrive sometime soon!



We can only hope, right? Please consider this a friendly service reminder that farm implements will be out and about in full force soon. Your patience and observance is important in guaranteeing safe travels on our rural roads.

Some tips to consider: If the farm implement you are following slows its' pace, it is most likely turning onto another road or into a driveway. Some equipment operators need to make wide turns into narrow driveways, so please hold back for a few more seconds and give them the space they need

to make the turn safely. Most farm equipment operators have several rear view mirrors, but when these operators are pulling additional equipment the mirrors don't always allow the operator to see everything, creating "blind spots". Lastly, please don't pass any farm equipment while traveling up a hill.

These points may seem like common sense, but as an equipment operator myself, I see this happen every year. Please stay safe this spring and allow a minute or two more travel time to reach your destination.

## BOARD & PLAN COMMISSION MTGS.

The Town Board's regular monthly meetings are on the 2nd and 4th Monday of the month. Meetings begin at 7:00 p.m., at the Town Hall, 5556 Twin Lane Road.

The Plan Commission meets on the 3rd Monday of the month. Periodically it has been necessary to change the dates and time because of conflicts. You can confirm the meeting date and time by checking the posted meeting notices, the town website or call the office.

Meeting agenda notices, ordinance adoptions, and other information are posted on the website and three town bulletin boards. The bulletin boards are located at the Town Hall, at 4167 CTH TT, and at the intersection of CTH N and Lonely Lane.

**Building Permits & Ag Site Permits** are issued by the building inspector, Chris Butschke. He has office hours at the town hall on Monday 9-10 a.m., 837-6688. He is often in the area and will meet with residents at other times. He can also be reached by calling 1-800-422-5220 or 608-576-6371. **Dane County** requires a zoning permit for all new structures and additions.
