

saved Jerry's life. Jerry was transported to the hospital ER where it took over an hour for two doctors, stitching the wound from both ends toward the middle, to sew him up.





Generation Park Update.... Eagle Scout Evan Newhouse Chooses The Town of Sun Prairie



Completing a community service project is the final phase to become an Eagle Scout. With the help from Joe and Diane Powelka, Lyle Updike and many volunteers, Evan Newhouse decided to install railroad tie stairs and also clear invasive species from walking paths at Generations Park in the Town of Sun Prairie. After accomplishing approval from the Town of Sun Prairie and the Glaciers Edge Boy Scout Council, the



volunteers and Evan spent many hours determining the materials needed to develop a plan. Evan used as many recycled materials as possible for the project to keep expenses down. Eighty feet of railroad ties cut into four foot sections were needed for the stairs; this made handling the ties manageable. Two holes were drilled into each four foot section for rebar to secure the tie into position. Mulch was delivered to the site by the Town of Sun Prairie; a six inch base of mulch was laid on the walking paths for weed control. Two of the

The Plan Commission holds regular meets on the 3rd Monday of each month and occasionally has a need for additional meetings. This money is turned around and used to reduce the special charge amount on property owners tax bill for trash & recycle collection. The recycling program was mandated in 1994. Tipping fees have increased and the recycling grant is being phased out. To offset the decrease in the grant the Town Board approved a proposal from Waste Management to participate in their recycle rebate program. The rebate amounts fluctuate with the market so it is difficult to predict what the rebate will be. However, it has worked well for the town residents the last couple of years.

The grant requires a continued high level of recycling. If the town falls below 82 pounds of recycled material per person,

per year we will not continue to receive the annual grant. Our amount for 2011 was 192 pounds per person. Keep up the good work and be mindful of recycling all that you can.

Winter Road Reminders

Winter usually brings some challenging road problems both for drivers and for people plowing the roads. The Town of Sun Prairie is proud to be able to clear the roads in a timely manner. The plow drivers prefer to tackle the job early, before the commuters and school buses are on the road.

Several reminders for winter driving consideration:

When you clean your drive, please do not push the snow across the road or into the road right of way. Snow and ice left on the road and the shoulder which has already been cleared, freezes hard and creates a real hazard. The sheriff will issue citations for this.

"The snowplow driver dumps snow in my drive all the time!" There is nothing the plow driver can do to prevent this problem, but the homeowner may be able to help. Clear an area next to the driveway along the shoulder. When the plow passes, the snow will windrow into that empty area instead of your drive.

Cul-de-sacs present a real challenge. Many have not been designed with the snowplow equipment in mind. There needs to be

enough open space in the right-of-way to allow for piles of snow.

Stay a safe distance behind the plow. You may think that the biggest risk of collisions involving snowplows is getting hit by one. In fact, most accidents occur when other drivers rear-end plows, according to the State Patrol. Snowplows often have to stop or slow down if they encounter an obstacle. State Law requires that you leave 200 feet between you and the plow. Following closer not only risks crashing, it may cost you a \$161 ticket. The driver will not be able to see you if you are close and you will be showered with road salt. As the plow drivers clear intersections they backup numerous times.

When there is a large snowfall the drivers are on the roads by 3:00 a.m. The main town roads are opened first then the subdivisions.

Blue reflectors should be used if you wish to mark your driveway or mailbox. The red, white or amber reflectors are easily mistaken for vehicles by the plow drivers.


