April 15, 2020**

**Call to Order:** Chairman, Lyle Updike called the meeting to order at 4:00 p.m. at the Town Hall, 5556 Twin Lane Road. Supervisor D Yelk, Supervisor J Seltzner, Clerk R Wiedenbeck, Treasurer K Weisensel, Patrolman W Dorshorst, Assistant Patrolman B Dodge were present.

**Statement of Public Notice:** Record in the minutes that the notice of this meeting was posted on three Town bulletin boards on April 9, 2020 and April 14, 2020.

**Pledge of Allegiance:** Treasurer K Weisensel led the pledge.

**Consider/Take Action:** Final Adoption of Town Zoning Ordinance Amendment of 1.0622 Kennel: secondary standards (2) Kennel Setbacks. From 1000 feet to 100 feet. Supervisor D Yelk made a motion to approve Ordinance Amendment of 1.0622. Supervisor J Seltzner seconded. Aye Votes: L Updike, D Yelk, J Seltzner. Nay Votes: None. Motion carries.

**Consider/Take Action:** Request from Ray & Mary Thomson to rezone Parcel #0811-074-9500-0, (17 acres) currently zoned A-2 (Agricultural District) & Parcel #0811-074-8320-0, (1 acre) currently zoned A-2 (Agricultural District) in Section 74 located at S. Bird St. The Thomson's would like to rezone both parcels to COM (Commercial) to build and operate a Doggy Daycare Facility. Supervisor D Yelk made a motion to approve the rezone along with the 'Conditional Use Permit' as previously stated with the additional condition of installing a Tree Line in front of the house to help provide a light and noise barrier. Supervisor J Seltzner seconded. Aye Votes: L Updike, D Yelk, J Seltzner. Nay Votes: None. Motion carries.

**Audit and Pay Bills:** Supervisor D Yelk moved to approve the bills as presented with the addition of The Kaski Park Bill for the sign, Generations Park Bill for the toilet, Board members pay and quarterly wages, and employee wages.
