**Pledge of Allegiance**: Treasurer K Weisensel led the pledge.

**Approve Minutes from Prior Meeting:** Supervisor J Seltzner made a motion to approve minutes from the two previous board meetings, seconded by Supervisor D Yelk. Aye Votes: L Updike, J Seltzner, D Yelk. Nay Votes: None. Motion Carries.

**Presentation of the Public:** None.

**Consider and take action**: Approve Zoning Change for Gary Ziegler Jr. – Section 30; Parcel 0811-303-9002-5(AG)(Legacy) to SFR (Town Zoning) 5048 Thorson Road, Sun Prairie, WI. This is for a formation of a 1-acre buildable lot and placing an additional 5 acres into a conservation easement.

**Consider and take action:** Approve Removal of verbiage on CSM "Reserved for Future Dedication as Public Road Right-of Way" and the building set-back line on the CSM for Dick Schwarz – Section 32: Parcel 0811-324-0056-4 (R-1)(Legacy) 2699 Sylver Ridge Ln, Sun Prairie, WI.

Consider and take action: Approval on a petition from Statz Bros., Inc., to rezone and construct a facility to produce biogas on parcel #0811-023-9175-6. Property located at 2108 State Rd. 19. This is a rezone of 2.5 acres to AG-EN and the remaining 25.5 acres would be AG-EX. There will be a conditional Use Permit outlining the requirements from the Planning Commission. This business practice plan will be reviewed every 5 years.

Specialized training for local EMS and Fire Unit at owner's expense. (6.) No engine braking within the Town of Sun Prairie. (7.) 5-year review of Conditional Use Permit to be conducted by the Town of Sun Prairie. Aye Votes: L Updike D Yelk, J Seltzner. Nay Votes: None. Motion Carries.

Patrolman W Dorshorst reported there was a road repair on Sylver Ridge Lane that needs to be completed.

They finished up 2 culverts in the township and have 2 more to complete.

Cottage Grove Business Development LLC Annexation, Petition #14212, for parcel #0811-333-8040-5 and 0811-333-8502-0 in the Town of Sun Prairie has been reviewed and found to be against the public interest because it will create a town island contrary to s. 66.221 Wis. Stats.

Resident Troy Statz discussed improving a route for the manure pipeline through Generations Park. Had a discussion and took no action.

Chairman L Updike received an email from Jerry Derr and they want to put a canoe launch on Town Hall Road, right at the bottom end of Patrick Marsh. Had a discussion and took no action.
