June 8, 2020**

**Call to Order:** Chairman, Lyle Updike called the meeting to order at 5:00 p.m. at the Town Hall, 5556 Twin Lane Road. Supervisor D Yelk, Supervisor J Seltzner, Clerk R Wiedenbeck, Treasurer K Weisensel, Patrolman W Dorshorst were present. Guests: Chris Janssen, Paul D Huggett.

**Pledge of Allegiance:** Supervisor D Yelk led the pledge.
