**Call to Order Public Hearing for the 2021 Budget:** Chairman L Updike called the Public Hearing to order at 7:04 pm at the Town Hall, 5556 Twin Lane Road. Supervisor D Yelk, Supervisor J Seltzner, Clerk R Wiedenbeck, Treasurer K Weisensel, Patrolman W Dorshorst, and Assistant B Dodge were present. Residents Mark Lydon and Ryan Erisman were also present.

**Approve Minutes:** Moved by Supervisor D Yelk, second by Supervisor J Seltzner to approve the minutes from November 30, 2020 Budget Public Hearing and Special Electors Meeting. Aye Votes: L Updike, D Yelk, J Seltzner. Nay Votes: None. Motion carries.

**To Authorize the Town Board to hire a town officer(s) as an employee and set an hourly wage pursuant to Section 60.10(1)(g) and Section 60.10(2)(L) of Wisconsin Statutes:**

Moved by Supervisor J Seltzner, second by Resident Mark Lydon to authorize the Town Board to hire a town officer(s) as an employee and to set the hourly wage at \$20.00 and \$30.00 for Holidays (part-time relief drive), not to exceed \$5000 pursuant to Section 60.10(1)(g) and Section 60.10(2)(L) of Wisconsin Statutes. Aye Votes: L Updike, J Seltzner, K Weisensel, M Lydon, R Erisman. Nay Votes: None. Abstain: D Yelk. Motion carries.

**To approve the total 2022 Highway Expenditures pursuant to Section 81.01(3) of Wisconsin Statutes:** Moved by Resident Mark Lydon, second by Resident Ryan Erisman to approve the 2022 Highway Expenditures of \$873,787 which is consistent with the budget summary pursuant to Section 81.01(3) of Wisconsin Statutes. Aye Votes: 6. Nay Votes: None. Motion carries.

**To Adopt the 2021 Town Tax levy of \$788,718 to be paid in 2022 pursuant to Sec. 60.10(1)(a) Wisconsin Statutes:** Moved by Resident Ryan Erisman, second by Treasurer K Weisensel to Adopt the 2021 Town Tax levy of \$788,718 to be paid in 2022 pursuant Sec. 60.10(1)(a) Wisconsin Statutes. Aye Votes: 6. Nay Votes: None. Motion carries.

**Authorize Town Borrowing pursuant to Section 60.10(1)(a) of Wisconsin Statutes:** Moved by Resident Mark Lydon, second by Resident Ryan Erisman to allow the Town Board to borrow up to \$30,000 over the total budget amount without authorization of the electorate. (A larger amount would require the approval of the electors of the Town at a Special Town Meeting.)

**Any other items as allowed by the electors at a Special Town Meeting, pursuant to Section 60.10(1) and (2):** None.
