**Approve Minutes:** Moved by Supervisor J Seltzner, second by Supervisor D Yelk to approve the minutes from November 11, 2019 Budget Public Hearing and Special Electors Meeting. Aye Votes: L Updike, D Yelk, J Seltzner. Nay Votes: None. Motion carries.
