## TOWN OF SUN PRAIRIE PLAN COMMISSION MEETING MINUTES June 20, 2022

Call to Order: The meeting of the Town of Sun Prairie Plan Commission was called to order at 5:30 p.m. The following members were present: Chairman, D Yelk, M Lydon, D Kalmerton, A Meyer, P Stang, J Case, J Tatar and Secretary, K Weisensel. Guests: Dan and Lori Kvalheim, Chad Fisher and Larry Buren, Representatives from Lakeshore Construction, Teri Hatchell, Representative from Charter Communications and Tammy Moodie.

Pledge of Allegiance: P Stang led the pledge.

**Statement of Public Notice:** Record in the minutes that the notice of this meeting was posted on the three Town bulletin boards and the Town website on June 16, 2022.

**Approve minutes from prior meeting:** P Stang made a motion to approve minutes from planning commission meeting, 5/16/22. Seconded by J Case. Motion carried.

**Preliminary Hearing:** on a request from Tammy Moodie on Parcel #0811-192-9575-0, 11.019 acres, currently zoned RH-3 (Rural Homes District), located at 3064 Nelson Rd. Tammy would like to split off 2.15 acres and build a new home for herself. She will sell the remaining parcel and buildings. After discussion, a motion was made to split off 2.15 acres with a separate driveway and rezone it to SFR (Single Family Residence) and the remaining will be zoned AG (Agriculture).

Motion by: P Stang Seconded by: M Lydon

Motion carried.

**Public Hearing:** on a request from Lakeshore Construction, to rezone Parcel #0811-222-8000-7, 4.119 acres, currently zoned A-1 (EX) (Exclusive Agriculture), located at 2256 County Highway T. Dan & Lori Kvalheim want to split this parcel into 2 lots and sell 1 lot to Charter Communications. Charter Communications currently leases this whole parcel and has a small communications building on it. They would like to build a new communications building and maybe put up a 30' communication tower. The Kvalheims would like to keep the other parcel and clean it up. A motion was made to rezone Lot # 1 to IND (Industrial) with a CUP, 1.966 acres, and Lot #2, will be zoned EA (Exclusive Agriculture), 1.455 acres and remain with the farm.

The Conditional Use Permit for Charter Communications includes the following verbiage:

- Size of new communications building is to be no bigger than 2,000 sq. ft.
- A communications tower is to be no higher than 30 ft. unless a new Conditional Use Permit is issued.
- Old communications building is to be tore down by December 31, 2025.
- Low outdoor lighting for security purposes only.

Motion by: P Stang Seconded by: J Case Motion carried.

**Update on Comprehensive Plan:** M Lydon and J Tatar gave a brief overview of the recent listening session, which was held on June 7<sup>th</sup>. They were happy with the turn out of Town residents both in person and via zoom. Some very good ideas and thoughts were brought up and were discussed. There is 1 more listening session scheduled for July 14<sup>th</sup>.
