## TOWN OF SUN PRAIRIE Regular Town Board Meeting October 24, 2022

**Call to Order**: Chairman, L Updike called the board meeting to order at 4:00 a.m. at the Town Hall, 5556 Twin Lane Road. Supervisor, D Yelk, Supervisor, J Seltzner, Patrolman, J Schuster, Clerk, R Wiedenbeck and Treasurer, K Weisensel were present. **Residents present**: Tammy Moodie, Dan Weisensel, Bryan Yoemans, Andrew Kirch, Joua Vang and Senior Client Specialist, Michelle Strauss from The Horton Group.

**Statement of Public Notice:** Record in the minutes that the notice of this meeting was posted on the three Town bulletin boards on October 20, 2022.

Pledge of Allegiance: Clerk, R Wiedenbeck led the pledge.

**Approve Minutes of Prior Meetings:** Supervisor, J Seltzner motioned to approve minutes from 10-5-2022. Supervisor, D Yelk seconded. Aye Votes: L Updike, D Yelk, J Seltzner. Nay Votes: None. Motion carries.

**Consider and Take Action**: on a request from Andrew Kirch on Parcel #0811-241-8770-3, currently zoned A-1(EX) (Exclusive Agriculture District), located at 5491 County Highway TT. Andrew would like to split off 5.357 acres and the existing home from the current 12.75 acres and rezone it to SFR (Single Family Residence). The remaining 7.393 acres would also be rezoned to SFR (Single Family Residence). The two properties will have a shared driveway. **Consider and Take Action**: on a request from Tammy Moodie on Parcel #0811-192-9575-0, 11.019 acres, currently zoned RH-3 (Rural Homes District), located at 3064 Nelson Rd. Tammy would like to split off 2.161 acres and build a new home. A new driveway will come off of Nelson Rd., for the new home. Supervisor, D Yelk made a motion to approve the rezone of 2.161 acres to SFR (Single Family Residence) and the remaining 8.858 acres will remain AG (Agriculture). Supervisor, J Seltzner seconded. **Consider and Take Action**: Complaint about a small engine business being run out of a home located at 2907 Vang Rd. that is currently zoned R-1 (Rural Home District). Joua Vang stated that his son-in-law moved in recently and wanted to run a small engine business. Joua is aware that he would have to rezone in order to do this. Joua stated that the extra gas tank that was in the ditch is gone and they are working on cleaning up all the lawn mowers and batteries on the lawn. No action was taken.
