Consider and Take Action: Approve and Adopt Amended Municipal Court Ordinance 2004-4. Supervisor D Yelk motioned to Approve and Adopt amended Municipal Court Ordinance 2004-4 as presented. Supervisor J Seltzner seconded. Aye Votes: L Updike, D Yelk, J Seltzner. Nay Votes: None. Motion carries.

Consider and Take Action: Approve Employee Handbook Changes. Supervisor D Yelk motioned to approve Employee Handbook changes. Supervisor J Seltzner seconded. Aye Votes: L Updike, D Yelk, J Seltzner. Nay Votes: None. Motion carries.

Road Report: Patrolman J Schuster reported he had both trucks checked out, and they are ready to go. Assistant Patrolman B Dodge came back to work today. Patrolman J Schuster did up a list of Job Duties for the Assistant Patrolman. The board reviewed the list and did not have any problems with it.

Old Business/New Business:

Supervisor J Seltzner brought up that he would like our Town Board Meetings to be conducted in a more-timely manner and that most meetings can be held to an hour or less than. The board agreed. Clerk R Wiedenbeck brought up the Cyber Liability Insurance options through Rural Insurance, we had 3 options: \$1,000,000 for \$2237 per year, \$500,000 for \$1782 per year, and \$100,000 for \$152 per year. The board chose the \$100,000 option for \$152 per year. This is the exact same coverage as the other two

options. The new Insurance premium amount with the changes should be \$19,309 per year. Supervisor J Seltzner moved to spend the \$19,309. Supervisor D Yelk seconded. Aye Votes: L Updike, D Yelk, J Seltzner. Nay Votes: None. Motion carries.

Patrolman J Schuster brought up the question: does Assistant B Dodge get the same 6.8% for retirement as the employees enrolled in WRS (Wisconsin Retirement System)? Chairman L Updike stated any employee opting out of WRS are under the old policy and will receive 6%. Chairman L Updike made a motion, advised the clerk, that the 6% for the pension in lieu of being in WRS is based on the employees' W-2. Supervisor J Seltzner seconded. Aye Votes: L Updike, D Yelk, J Seltzner. Nay Votes: None. Motion carries.

Items for next meeting agenda: Authorizing Clerk and Treasurer to pay routine bills through end of calendar year.
