## TOWN OF SUN PRAIRIE APPLICATION FOR DOG LICENSE

Please return entire form for Dog License

All dogs 5 months or older must be licensed and should carry a tag. License tags for dog owners and kennels are \$20.00 for **<u>each</u>** neutered male and **<u>each</u>** spayed female, \$30.00 for **<u>each</u>** un-spayed female and **<u>each</u>** un-neutered male. To receive a license the form MUST be completed including date of vaccination and expiration date, and proof of rabies vaccination (including the vaccination date) from the veterinarian needs to be sent or brought in when getting your dog license. A copy will be made and kept on file at the town office. If you are mailing your license fee please **<u>enclose a self addressed, stamped</u> envelope** so the tags can be mailed to you.

A \$5.00 late fee will be charged to every owner of a dog 5 months of age or over if the owner failed to obtain a license prior to April 1 of each year, or within 30 days of acquiring ownership of a licensable dog or if the owner failed to obtain a license on or before the dog reached licensable age. This late fee shall be charged in addition to the required license fee.

## NOTICE TO DOG OWNERS

**STATS 95.21(10) PENALTIES.** (a) Failure to obtain rabies vaccination. An owner who fails to have a dog vaccinated against rabies as required under sub. (2) (a) may be required to forfeit not less than \$50 nor more than \$100.

**STATS 95.21(2) RABIES VACCINATION REQUIRED FOR DOGS**. (a) the owner of a dog shall have the dog vaccinated against rabies by a veterinarian at no later than 5 months of age and revaccinated within one year after the initial vaccination. If the owner obtains the dog or brings the dog into this state after the dog has reached 5 months of age, the owner shall have the dog vaccinated against rabies within 30 days after the dog is obtained or brought into the state unless the dog has been vaccinated as evidenced by a current certificate of rabies vaccination from this state or another state. The owner of a dog shall have the dog revaccinated against rabies by a veterinarian before the date that the immunization expires as stated on the certificate of vaccination or, if no date is specified, within 3 years after the previous vaccination.
