TOWN OF SUN PRAIRIE Regular Town Board Meeting June 26, 2023

Call to Order: Supervisor D Yelk called the board meeting to order at 4:00 p.m. at the Town Hall, 5556 Twin Lane Road. Supervisor J Seltzner, Clerk R Wiedenbeck, Treasurer K Weisensel and Patrolman J Schuster were present. Absent: Chairman L Updike. Guests: Paul Sogan from Poblocki Paving, Ron Treinen, Adam and Kayla Weisensel.

Statement of Public Notice: Record in the minutes that the notice of this meeting was posted on the three Town bulletin boards on June 22, 2023.

Pledge of Allegiance: Resident Adam Weisensel led the pledge.

Approve Minutes of Prior Meetings: Supervisor J Seltzner motioned to approve minutes from 6-12-2023. Supervisor D Yelk seconded. Aye Votes: D Yelk, J Seltzner. Nay Votes: None. Motion carries.

Presentation from the Public: Mr. Paul Sogan from Poblocki Paving received a letter from Supervisor D Yelk stating the parcel located on Hwy N & TT, located next to Steven's Construction, and which, Steven's Construction is using it for storage, does not have the proper zoning for this use. Mr. Sogan asked if we could hold off on the zoning requirement until they sell the parcel. The board agreed to hold off on requiring them to rezone until the property is sold, they have until 1/1/24. If it is not sold by 1/1/24, they would be required to rezone at that time. Mr. Sogan asked if Steven's Construction can continue to use it for storage. The Board agreed as long as Steven's keeps the property orderly.

Resident Adam Weisensel asked, "Why does the Planning Commission need to approve all "Conditional Use Permits" (CUP), even for sanitary fixtures in out buildings. Why can't they go directly to the Town Board"? Supervisor D Yelk replied: A CUP is a change of use of the property and is just short of a rezone. This change is for use beyond ordinary use, that's why conditions are being set. This change could affect the neighbors, which requires a public hearing, which is held at the Planning Commission level. This allows neighbors to voice their concerns in regards to this change. This is why a CUP is done at this level.
