If you do not choose a party and you vote in more than one party, no votes will be counted. 		
<p>Special Instructions for Presidential Preference Vote</p> <p>Choose the party in which you will vote. Within the party you have chosen, you have ONE of three choices:</p> <ol style="list-style-type: none"> Vote for a candidate whose name is printed on this ballot in the party you have chosen. Vote for an uninstructed delegation from Wisconsin to the national convention of the party you have chosen. Write the name of another person to become the presidential candidate of the party you have chosen. <p>Fill in ONE oval in ONE party.</p>
